Mike Hannigan

Co-Founder and President Give Something Back

Mike Hannigan was born in Pensacola Florida. He earned his B.A. in Philosophy from U.C. San Diego and his M.A. in Criminology from U.C. Berkeley. He began work for the Xerox corporation and built his career in management for business products companies for the next decade until starting GSB. Mr. Hannigan states, "I was active in the usual social movements of the late '60s and '70s, and although I was very successful as a businessperson, I was never really comfortable in that role and never happy unless I was involved in some type of community political activism. I approached Sean Marx with the idea of forming a company that would combine our business skills and our values. We saw an opportunity to use the power of business to further the goals of community service through funding non profit organizations. We started the company in 1991 with \$20,000 each from our savings and started making sales calls from my living room."

Jeanne Woodford

Senior Distinguished Fellow Chief Justice Earl Warren Institute on Law and Social Policy University of California, Berkeley School of Law

Ms. Woodford is a Senior Distinguished Fellow at the Chief Justice Earl Warren Institute on Law and Social Policy. She began her career at San Quentin State Prison in 1978 following graduation from Sonoma State University with a Bachelor's degree in Criminal Justice. Ms. Woodford was promoted through the ranks and was appointed Warden of San Quentin State Prison by Governor Davis in 1999. She remained Warden of San Quentin until called upon by Governor Schwarzenegger in 2004 to serve as the Director of the California Department of Corrections. Her mission was to bring reform and rehabilitation to the California Department of Corrections. She was appointed to the position of Undersecretary of the California Department of Corrections and Rehabilitation, the largest correctional system in the United States in July of 2005. Ms. Woodford then became the Chief of the San Francisco Adult Probation Department. She retired in 2008 completing 30 years of work at the state and county level of government in the field of criminal justice. Ms. Woodford is currently offering her expertise on several criminal justice reentry and policy projects throughout the state of California.
